### Praise on the Prairie

### OFFICIAL CONTEST RULES

## **CONTEST DESCRIPTION:**

The Praise on the Prairie contest ("Contest") will begin on Monday, November 19, 2012 and end on Friday, December 7, 2012 ("Contest Period"). This Contest will be conducted exclusively online. ## **HOW TO ENTER:**

Listeners of WTLC-AM ("Station") who are legal residents of the U.S. residing within the Indianapolis, IN metropolitan area, and are 18 years of age and older will be able to take part in this Contest. To participate in the Contest, listeners must do the following:

- 1. Listeners must log onto www.praiseindy.com and upload a two (2) minute video performance of their choir between Monday, November 19, 2012 and Sunday, December 2, 2012 ("Submission Period").
- 2. Upon entering the Contest website, participants are to follow the on-screen instructions, including entering their name, date of birth, address, phone number, email address, submitted entry, and any optional or additional contact information, as requested, to register for a chance to win.
- 3. All Internet entries must be received by 11:59pm local time on Sunday, December 2, 2012, or they will be void.
- 4. Eligible submissions will be posted online for public voting beginning on Monday, December 3, 2012.
- 5. Listeners will be able to vote for their favorite video submissions Monday, December 3, 2012 until Friday, December 7, 2012 ("Voting Period").
- 6. The submission with the highest number of votes at the end of the Voting Period will be selected as the winner.
- 7. One (1) entry per contestant per email address during the Contest Period.
- 8. In the event of a dispute regarding the identity of a participant's online entry, the entry will be deemed to have been made by the authorized holder of the e-mail account at the time the entry was made.
- 9. By uploading a submission and entering this Contest, each participant represents and warrants to be bound by the Official Contest rules, that they are authorized to and have the rights to submit the content in the entry, and that all of the below-listed requirements have been met.

# **VIDEO ENTRY REQUIREMENTS:**

- Entries must not exceed two (2) minutes in length
