

# 2015 Focus Areas Goals and Objectives

Indianapolis Metropolitan Police Department

- 1) Reduce violent crime in focus areas by 5 percent (criminal homicide, rape, non-fatal shootings, robbery)
- 2) Decrease citizen perception or fear of crime by 20 percent.
- 3) Increase property crime arrests in focus areas by 2 percent with the goal of reducing property crime (burglary, graffiti, vandalism).
- 4) Documented increase in juvenile participation in Community Affairs Programs.
- 5) Documented increase in the amount of incoming community tips and crime information.

### Indianapolis Fire Department

- 1) Reduce number of structure fires in focus areas by 5 percent.
- 2) Reduce civilian fire fatalities by 10 percent.
- 3) Increase juvenile arson completed interventions to 75 percent of contacts.
- 4) Complete 90 percent of building inspections in focus areas within six months.
- 5) Provide first response in four minutes and full company in eight minutes in focus areas. (90% or greater achievement).

## Indianapolis Emergency Medical Services

- 1) Provide transport ambulance response times under 10 minutes in focus areas. (90% or greater achievement).
- 2) Documented reduction in the number of overdose deaths in focus areas.
- 3) Documented improvement in the patient ratio of shootings to homicide.
- 4) Reduce IEMS mental/emotional calls in focus areas by 10 percent.
- 5) Documented reduction in non-emergent use of IEMS system in focus areas.

### Division of Homeland Security

- 1) Establish a data analysis unit in conjunction with MESH.
- 2) Coordinate and track all focus area initiatives and activities.
- 3) Host focus area meetings with partners and community.

### Animal Care and Control

- 1) Hold a micro-chipping event in each of the focus areas with the goal of providing free dog micro-chipping.
- ACC will work with the Indianapolis Animal Welfare Alliance (IAWA) groups to create and distribute a holistic set of handouts, brochures, informational packets and resource listings in a one-day blitz in each of the focus areas.
- ACC will coordinate the various local enforcement agencies including DCE, IMPD, Marion County Health Department and others, to combat dog-fighting incidents in the focus areas. This team will work with residents and other stakeholders within each of the focus areas.

### Public Safety Communications

1) Determine three-year monthly history for 911 (emergency), 3811 (non-emergency), and 211 (service providers) calls. Show monthly decrease in 911 calls shifting to 3811 and 211.

### Mayor's Office of Re-Entry

- 1) Identify 100 individuals who are most at-risk to re-offend in the six focus areas and engage them in wraparound services.
- 2) Establish six qualified/certified resource centers to serve the focus areas.

### Citizens Police Complaint Office

- 1) Identify number of complaints received in focus areas and create contact response card with goal of no reoccurrence.
- 2) Identify complaint patterns that might exist for district training follow-up.
- 3) Have a CPCO staff member attend all focus area community engagement meetings.
