This letter is to serve as the official 90-day closing notification that JPMorgan Chase Bank, N.A. (the "Bank") intends, on or about October 15, 2015, to close its branch facility located at 3950 Meadows Drive, Indianapolis, Indiana 46205 (the "Banking Center"), which site is situated in a low income census tract area, and is certified by the Office of the Comptroller of the Currency (the "OCC") as branch #096312A. This notice is provided as required by the Federal Deposit Insurance Corporation Improvement Act of 1991 (the "Act"). Please be advised that the Bank will provide a notice of closing to the customers of the Banking Center on July 17, 2015. A copy of the customer notification is annexed hereto.

Additionally, it is the Bank's intention to consolidate the Banking Center with and into the Bank's Keystone branch facility, certified by the OCC as branch #004940A, located at 5236 North Keystone Avenue, Indianapolis, Indiana 46220, approximately 2.2 miles away. This site could serve as an alternate location for customers of the Bank.

In accordance with 12 U.S.C. 1831r-1(a), the Bank has carefully reviewed and considered the potential impact of the Banking Center's closing on the Bank's obligations under the Community Reinvestment Act and has determined that there will be no material adverse impact.

The following is a summary of the reasons for closing the Banking Center: as of the date of this letter, there are four branches of the Bank and ten offices of competing financial institutions with a total of 15 branch offices all within a three-mile radius of the Banking Center. The consolidation is being recommended for the Banking Center due to the decline of the retail trade area, which has caused the Banking Center to experience low volume transactions. Therefore, in light of other branch locations in close proximity and because there does not appear to be any indication that any new development will occur in the near future that would help the branch performance improve significantly over time, the decision to close the Banking Center was made.

# Dear Licensing Manager:

Effective with the close of business on April 30, 2015, JPMorgan Chase Bank, N.A. (the "Bank") consolidated its branch located at 5718 Crawfordsville Road, Indianapolis, Indiana 46224, (the "Banking Center") located in a moderate income census tract area, authorized by the Office of the Comptroller of the Currency (the "OCC") as branch #148573A, with our branch located at 2302 Cunningham Road, Indianapolis, Indiana 46224, authorized by the OCC as branch #015886A (the "Target Branch").

The consolidation of the Banking Center into the Target Branch complies with the requirements of the Joint Policy Statement on Branch Closings issued on June 29, 1999 by the following agencies: Office of the Comptroller of the Currency, Treasury, Board of Governors of the Federal Reserve System; Federal Deposit Insurance Corporation and Office of Thrift Supervision, and meets the distance requirements of 12 C.F.R. Section 5.3(1). The distance between the Banking Center and the Target Branch is approximately 500 feet. The city of Indianapolis is a central city of a Metropolitan Statistical Area ("MSA") and in compliance with the Joint Policy Statement, consolidation of offices within one thousand feet and located within a central city of a MSA are considered relocations that do not substantially affect the nature of the business or customers served. In this instance, the Banking Center and the Target Branch are located in the same neighborhood and the nature of the business and the customers served are not affected.

The following is a summary of the reasons for closing the Banking Center: as of the date of this letter there are five branches of the Bank and ten offices of competing financial institutions with a total of 19 branch offices all within a three-mile radius of the Banking Center.

The consolidation was recommended based on the decline of the retail trade area, which has caused the Bank to experience low volume transactions and in light of other branch locations in close proximity, the decision to close the Banking Center was made.

This letter is to serve as the official 90-day closing notification that JPMorgan Chase Bank, N.A. (the "Bank") intends, on or about August 20, 2015, to close its branch facility, located at 2955 Martin Luther King Jr. Drive, Indianapolis, Indiana 46208, (the "Banking Center"), which site is situated in a low income census tract area, and is certified by the Office of the Comptroller of the Currency (the "OCC") as branch #004939A. This notice is provided as required by the Federal Deposit Insurance Corporation Improvement Act of 1991 (the "Act"). Please be advised that the Bank will provide a notice of closing to the customers of the Banking Center on May 22, 2015. A copy of the customer notification is annexed hereto.

Additionally, it is the Bank's intention to consolidate the Banking Center with and into the Bank's North Meridian branch facility, certified by the OCC as branch #003776A, located at 2829 North Meridian Street, approximately 1 mile away. This site could serve as an alternate location for customers of the Bank.

In accordance with 12 U.S.C. 1831r-1(a), the Bank has carefully reviewed and considered the potential impact of the Banking Center's closing on the Bank's obligations under the Community Reinvestment Act, and has determined that there will be no material adverse impact.

The following is a summary of the reasons for closing the Banking Center: as of the date of this letter, there are five branches of the Bank and ten offices of competing financial institutions with a total of 30 branch offices within the same three-mile radius of the Banking Center. The consolidation is being recommended for the Banking Center due to the decline of the retail trade area that may be a contributing factor to a number of recent Banking Center burglaries. Due to safety concerns for the Banking Center's employees and its customers, the Bank has decided to permanently close the facility effective August 20, 2015.

Additional details with respect to statistical and other data regarding the closing will be made available to the OCC at the time of the next applicable examination of the Bank or upon request.






